

# Racism From Washington To Weatherford

Washington Jan 7, 1905

......During the course of Bard's speech he was interrupted by Mr. Tillman who said he wanted to make an appeal for "White supremacy in Arizona". ....and to subject the white people of Arizona to the domination of Mexicans and "greasers" which he opposed. Extracted From the Weatherford Weekly Herald.

(Train bringing in Mexicans to work on the coal mines) "....having on board thirty-two Mexican miners for the Rock Creek (Parker County no longer there.) coal mines...they were "greasers one and all." The Texas Miner, June 16, 1894.

According to those that practiced racism it was protected speech under the 5th Amendment. The Civil Rights Act made racism go concealed. For those of us that felt the full impact of racism the 5th Amendment left a foul taste in our mouth. To be called every racial slur in existence is not enjoyable. Yes, we ate crow for breakfast, lunch and dinner. Thanks to the Civil Rights Act the menu changed.

Then comes Donald Trump speaking of Mexicans and Muslims. I find this offensive campaign rhetoric. I do not expect that racism will be obliterated in my lifetime or that of my grandchildren or great-grandchildren. America faces enormous challenges in the future. # The Divde Between Migrants Living In Texas

During the 19<sup>th</sup> and early 20<sup>th</sup> centuries almost a half-century after the annexation of Texas in 1845, the flow of Hispanics entering were barely a trickle. In fact, there was a significant migration in the *other* direction according to Times Magazine's Julia Young whom is currently researching Mexican immigration to the U.S. during the 1920s. According to Young, during the 1890s, new industries in the U.S. Southwest — especially mining and agriculture — attracted Mexican migrant laborers. As the number of different ethnicities from different parts of the world migrated to Texas, Mexicans were sometimes said to have certain positive qualities that made them "better" labor immigrants than the other groups.

As of now there is a negative migration rate to Mexico. But there are still migrations to Texas from Mexico whom have moved to the United States of America, but Hispanics from Mexico migrating to Texas might not be welcomed by their own cultural dialect and cultural traditions. There are several districts of Mexico whose residence may be foreign to those from the Eastern to the Western and Northern to the Southern parts. In 2000 approximately 20 million American residents identified themselves as either Mexican, Mexican-Americans or of Mexican origin, making it the sixth most cited ancestry of all US residents. The National Institute of Statistics and Geography forecasted in 2000 that about eight million Mexican-born individuals live in the United States of America. That is 8.7% of the total Mexican population.

In that same year, the Institute stated that the states with the greatest number of emigrants to the United States were Jalisco 793), Michoacán (165,502) and Guanajuato (163,338), with the total number of emigrants being 1,569,157. The great majority of these were men. Approximately 30% of emigrants come from rural communities. That same year, 260,650 emigrants returned to Mexico.

Many Mexicans can't speak fluent English and studies show that their ability to speak English doesn't improve drastically whilst they live in the US. This is largely due to them living in closed communities of other Mexican immigrants which reduces their need to assimilate with America. Just as well, the different Mexican dialect spoken in different regions of Mexico can in turn, create tension between migrants and locals, which in extreme cases, can lead to segregation, crime and violence.

In the following months of the Nuestra Voz publication these topics of segregation between the recent Mexican immigrants to Texas and those whom have been accustomed to Texan culture will be studied through interviews of different sources who can justify these differences, which do not enable productive social outcomes for those living as migrants to Texas from those Hispanics who now have to share cultural differences with their new neighbors.



## MCFARLAND USA, THE REST OF THE STORY:

JOEL LOPEZ WAS AGE 7 WHEN MCFARLAND HIGH SCHOOL WON ITS FIRST TITLE.

"I really knew nothing about McFarland's success or their first title. I just knew I loved to compete but football was my sport. Mr. Lopez and I were discussing the history surrounding the story and the quite good, inspiring, exciting movie, McFarland, USA. Ruben Ozuna, McFarland High coach Jim White's assistant, got Joel Lopez involved in running. Although not portrayed in the movie about the Southern California school and Jim White, Mr. Ozuna invited 8th grader Joel to compete in an annual relay race in Lake Tahoe. This was in the summer of 1993. And compete, Joel did. He went on to McFarland High, where he won numerous awards, such as All-League Runner, All-Valley, Most Valuable, among others, and he was the athlete with the highest GPA. I then asked Mr. Lopez about his relationship with the now legendary coach Jim White, portrayed in the movie by Kevin Costner. He noted that in movie Mr. White rode around in a what looked like a lowrider or for sure a kids bike, it was a regular beach cruiser, it became a tradition for the team to chip in and by him a new one every year.

"He was like a father figure to me. My greatest memory of him as a runner was at my McFarland Senior Banquet, when he called me his friend. This meant more to me than any award or championship." Mr. Lopez said he spent a lot of time taking care of Mr. White's house, feeding his chickens and watering his lawn, when he was out of town. "I felt he trusted me and that meant the world to me," Mr. Lopez said. And now their relationship has come full circle. Joel Lopez is McFarland's head cross country and track coach. It's almost like a son taking over the family business from dad. Mr. Lopez's feelings have not changed much; Mr. White remains a mentor and a friend. Mr. White now retired spends his time speaking around the country about how relationships contribute to success. Mr. Lopez admitted that his coaching style is much like Mr. White's. "I

challenge my runners to give me their best through positive reinforcement. I treat them all as individuals," Mr. Lopez said. "I try to have a real relationship with each runner; I treat them much like I would my own children. "McFarland's winning has resulted in the team being moved up to Division 5 status, for much larger schools than McFarland. It translates into McFarland playing teams from schools with five times the student population of McFarland. The reasoning behind this required redistricting, as we would call it in Texas, seems too simple: Mc-Farland wins too often! Mr. Lopez's winning teams have led to him being dubbed Coach of the Year several times in the last seven years. "At times it feels like a David versus Goliath but our team is up for the challenge" Joel said. Although Mr. White has continued to be a friend and role model, another person has come to be like Mr. Lopez's big brother - "and a role model to our whole team," Joel Lopez said. That someone is Mr. Ruben Ozuna. If we asked him for anything, and he

knew it would have a positive effect on us, he would never deny us," Mr. Lopez said.

Mr. Ozuna was one of the original runners on the team, starting in the early 80s, not 1987 as portrayed in the movie. Mr. Ozuna went on to become Mr. White's right hand man. But when asked by movie producers if he wanted to be portrayed in movie, Mr. Ozuna said, "No." I believe that speaks volumes about Mr. Ozuna's character and what's truly in his heart. He's not unlike many of the silent heroes in our own community. Clearly, Mr. Lopez, his staff and, of course, his athletes have continued McFarland/White/Ozuna's winning tradition, not unlike that portrayed in the movie. How does Mr. Lopez's students feel about the movie? "They were excited and proud, all positives. As for me, I was also proud," he said. "It also made me nervous and put more pressure on us to succeed." The McFarland-area community voice a lot of pride, and the community has had something of an invasion of tourists since the movie's release. Mr. Lopez said about 40 percent of the movie was shot on location, such as scenes on the track practice field, at the carwash and the store, a block from Mr. Lopez's mother's home. He said all the visiting actors and Disney movie-making personnel treated everyone in the McFarland area with respect. Many of the actors came to the school and spoke to Mr. Lopez's classes; Mr.

The actors who portrayed Danny and Victor in the movie were former students and runners for McFarland, in 2011 and 2012. Mr. Lopez was offered a part in the movie, but the offer came during track season. So he, not unlike

biology and has taught English lan-

his immediate predecessor, Mr. Ozuna, chose his team over the bright lights of Hollywood. Coach Ozuna is now teaching PE in Middle School and spending as much time as he can with his own kids. Some of Mr. Lopez's coaching assistants and some McFarland runners at the time of filming were hired as extras in the movie. Mr. Lopez has taught all the subjects in the middle school curriculum during his 16 years of coaching and teaching. His teaching philosophy mirrors his approach to coaching: Build an effective, trusting, honest relationship first and then teaches the general concepts and the details. The student and the runner come first; then come the running and/or the academic subject. "The greatest lesson Mr. White taught me was have a personal relationship with each individual, and all else will fall into place," Mr. Lopez said. Coach Lopez still has ties with all involved in McFarland's success in addition Johnny Samaniego and David Diaz are his Compadres. In closing I decided to get a lot more insight on Mr. Lopez's thinking, so I asked him the following questions;

What do you think is the most important issue effecting our community's progress?

"The ability for our community to work together as a whole"

What would you say to youth struggling to stay in school?

"Find something you love or someone you look up to and spend some time with them" Learn there are ways to get involved in positive actives" Take a chance on the good stuff."

What would you say to parents?

"Provide as much positive reinforcement as you can, spend quality time with your kids, have a lunch or dinner date with your kids and ask them, how they can be of help.

"In closing Mr. Lopez said "Success comes in many forms. It's not necessarily measured by how much money you make or how many championships you win. It's all about relationship one shares with each other, It always brings out the best in us" (Joel Lopez has been married to his wife Isela his High School Sweetheart for 18 years and they have 4 daughters Grace, Sarah, Emily and Joelle and he counts them as his biggest supporters)

Coach Lopez and his McFarland team will be coming to Arlington to compete. Details on the schedule will be reported here as the information becomes available.

# Reorganization of Fort Worth ISD

You may have heard the news. FWISD is going under construction. Our new Superintendent hit the ground listening. He heard



what he suspected...that we are too top heavy. The Board approved his request to cut the Cabinet down from 20 people to a new Leadership Team of 10. The move will save the school district roughly \$1.3 million a year. We will be flattening out the organization and pushing resources out to the schools that are in desperate need.

An exciting part of this move is the creation of an Equity and Excellence Department. Dr. Scribner knows FWISD is Good, but we want to be Great. The first step is to speak openly and honestly about the Achievement Gaps, hiring practices, curriculum, and district trainings. The challenges we face will require courageous conversations. An Equity and Excellence Department will be tasked with addressing those challenges.

FWISD is doing great things in collaboration with parents and community.

- 1. Parent University has expanded to 7 other schools which include Rosemont Elementary, Diamond-Hill Elementary, and WJ Turner. Manuel Jara Elementary had 90 parents involved this past academic school year.
- 2. North Side High School hosted the biggest Noche de Cienca in Fort Worth by hosting over 150 students, 60 parents, and 50 engineers from Lockheed Martin. There is a huge gap in engineers and local companies are challenging FWISD to produce Latino/Latina professionals.
- 3. February 3, 2016 Diamond-Hill Jarvis and Meacham Middle attended the Fort Worth Stock Show and Rodeo. Big thanks goes to Mr. Ed Bass, Steve Murrin, and Sasha Camacho for making it possible. North Side attended February 4th. Over 100 students attended each day. They got to go behind the scenes, enjoyed a delicious lunch, and watched the rodeo.

# FWISD Parents as Teachers-Home Visitation Program

The Parents as Teachers-Home Visitation Program is a free early childhood program for parents and children from Prenatal to school entry. The program is designed to assist parents in preparing their child for kindergarten. A certified social worker visits the parent and child in their home twice a month until the child is ready to start school. The visits are designed in assist good parents in becoming great parents. The program has 4 dynamic components they are; personal visits done in the family's home, group connections with other parents and children at a school site, screenings and an access to a resource network. Areas of emphasis in the model components are parent-child interaction, development-center parenting and family well-being. The social workers each are assigned a school pyramid in the FWISD, but are not bound to only that area. They have the flexibility to enroll any family that lives in the FISD boundaries. They do have a maximum case load of 20 families each and spots are filling very quickly. The only two requirements to be enrolled on the program are to have at least one child between the ages of prenatal and 5 years old and live within the FISD boundaries. # The 'Ice Man': Honors' Student, Pro Quarterback/ Coach, Latino Legend

Tom Flores - Academic All-American, first Latino starting quarterback in American professional football history, first Latino head NFL coach and the rare winner of two Super Bowls - was born in California farming country.

Early in his pro career Tom Flores was tagged "The Ice Man" - being cool under pressure and



adept at come-from-behind wins. He wasn't just the first minority head coach to win a Super Bowl; he was the first minority to become president and general manager of a U.S. professional football team. Only Tom Flores and Mike Ditka have ever won pro-football championships as a player, assistant coach and head coach.

Roots in Soil

Born Thomas Raymond Flores on March 21, 1937, in Fresno, he would learn how to work in the fields around Sanger, Calif. He was named for his father, who immigrated from Durango, Mexico, and like his father did early in his new U.S. home, the young Tom Flores spent a lot of time picking grapes. Tom learned how to work with his hands, but he had his sights set far beyond the California vine-yards that he saw almost daily as a child. Now 76, Flores received some early childhood advice from his parents, advice that he took to heart: "If you want to do something big, you have to roll up your sleeves and get to work; you find a way to get things done."

The young Thomas attended Sanger High School and was a high achiever on and off the field. He was an accomplished student; he earned an academic scholarship to Fresno State (later renamed

University of the Pacific).

I recently took an opportunity to chat with Tom Flores on the phone, from his California home. I asked him if he ever had to deal with discrimination, growing up and as an adult. "In high school, I know it was there, but I always tried to rise above that; I think if you look for it, you will find it," Tom said. "In the Pros, there was blatant prejudice in the south against the Black players. As for myself, I guess I kind of flew under the radar," he said. "Most people, especially in the north, did not know what to make of a Chicano."

From College to the Pros

Tom won the starting quarterback role for two seasons at Fresno State; additionally, he was active in Student Council and served as president of The Men's Associated Students group.

He was named Academic All-American. His parents' advice was not lost on him. But he was destined to accomplish more, much more despite suffering a shoulder injury during his senior year at Fresno.

"This hurt my chances of getting drafted, especially since back then (1958), there were not that many teams, and the American Football League was not even in existence yet," Tom recalled.

Graduating from college, he focused on pursuing a career in professional football, a lofty goal for any athlete, but especially one coming out of a small college and one who was a Latino before that term was commonly used or used with respect or pride. At best, back then when people were being half-way civil, Tom likely was called a Mexican. Today that's a label of pride, too, in many Hispanic circles.

Although the National Football League did not call, the Canadian Football League did. So, Tom went north to Canada and joined the Calgary Stampede football team in 1958. Tom, however, met more than his share of adversity. He was cut after one season. But his dream was not lost; he didn't give up. The Washington Redskins of the NFL picked him up in 1959. His stay didn't last long; his shoulder injury from college days came back to haunt him. He was released by the 'Skins, and he underwent shoulder surgery.

Tom returned to college: "I was preparing for life after college and was working on my master's degree when I got a call from a new team, from Oakland.' Not just a new team, the Oakland Raiders were in a new league, the AFL. So in 1960 Tom became a Charter member of the American Football League. As a Raider, Tom was to enjoy most of his pro successes as a player and later as a coach. He was named starting quarterback, thus becoming the first Latino starting QB in American professional football history, all leagues. In his first year as the starter, he passed for 1,738 yards, completing 54 percent of his passes, connecting on 12 touchdowns. Those numbers are not impressive by today's standards, but in that era, running the ball was always the number one weapon for all teams. Indeed, Tom's passing stats that year led the league, AFL.

As Raider QB, Tom was dubbed "The Ice Man" for his ability to keep his cool under pressure and bring his team back from scoring deficits to win. Tom stayed with Oakland until 1967, by far his longest stay with any team; then he was traded to Buffalo. Tom stayed with the Bills until 1969; he was traded to Kansas City and helped win an AFL championship there as a backup QB. In 1970, after the AFL and NFL merged into the National Football League, Tom retired as a player, with a record of 838 completions on 1715 attempts, gaining 11,959 yards and 92 passing TDs. He also rushed for 5 TDs.

Coaching

Tom started his coaching career in Buffalo under Sid Gillman. But he was soon back with Oakland, where he would reach his crowning achievement. In 1979, Tom was named the Raiders head coach when John Madden retired. The promotion made Tom the first minority head coach in the NFL, in both divisions. Tom Flores went on to lead the Raiders to two NFL championships, against the Eagles in Super Bowl XV and against the Redskins in Super Bowl XVIII. Jerry Jones-X-2

What I find even more admirable were Tom's achievements with the Raiders, the team owned by Al Davis, who was known for his impatience and constant meddling in team management, coaching and recruiting. Many sports history buffs call Davis the original Jerry Jones-TIMES-TWO.

I asked Tom about his relationship with Al Davis. "Sure he was tough to work for at times," Tom said, having worked for Davis as a player/assistant coach and as a head coach. "He was tough, but for the most part, he was fair, but at times . . . unreasonable." How did Davis and Jerry Jones compare? "When Jerry bought the Cowboys, he . . . sought out Al for advice," Tom said. "This led to them becoming friends." Tom said it's possible that Jerry did take to heart the early counsel of Al Davis. "But again," Tom said, "If you win, nobody will second-guess you." For Davis and anyone in the business then and now, Tom said, "the bottom line . . . is winning. If you win, you can do no wrong. If not, you will be in the hot seat." So, to quote the late Al Davis: "Just win, Baby." Davis was once quoted as saying that Tom "is not just a great coach in the league," but that Tom "is among the

And as the business proved, Tom knew, a coach is only "as good" as his record at any given moment. Davis removed Tom from the head coaching job and moved him upstairs in Oakland management and later fired Tom from that job and all Oakland roles. It proved to be another opportunity. Tom was named

general manager of the Seattle Seahawks and later, in 1992, became the team's head coach. After three disappointing seasons, Tom was let go.


Overall, Tom compiled a coaching record of 97 wins, 87 losses and no ties, with a playoff tally of 8 wins and 3 losses - and of course, the two Super Bowl victories. Tom recalled his Super Bowl quarterback, Jim Plunkett. "He was a very talented quarterback and also the first and only Latino to win the Heisman Trophy. He is of Mexican descent on his mom's side." Does Tom foresee another Hispanic quarterback and head coach combo in the NFL?

"There will likely never be again," he said. Tom never regained the magic of his Oakland days. The Football Gods giveth and taketh away.

Honors y Mas

Tom Flores has been recognized on many occasions for his philanthropy, including being presented the Roberto Clemente Award by National Council of La Raza, being named to the California Sports Hall of Fame and having the football stadium at his alma mater, Sanger High School, named for him. When considering Thomas Raymond Flores's whole body of work, including being a charter member of the old AFL, I and many other pro football fans and many experts argue that "The Ice Man" deserves to be in the NFL Hall of Fame. I asked him about the induction possibility. "It, of course, would be an honor," Tom said. "My last chance will not come until four or five years down the road, as an old-timer pick." Regardless, Tom Flores is a prime source of pride for the Latino community,

For now, he's still involved in football, as color commentator for the Oakland Raiders Network. He plays golf; one course is a short walk from his home. His advice for anyone with a dream is: "Have passion for your chosen career, and be prepared for setbacks. They will only make you stronger and smarter." Tom is married; he and his wife Barbara have three grown children, twin boys and a daughter, and five grandchildren.

## Un sueño perdido por Alfredo Sánchez

Los miembros de la Liga de Ciudadanos Latinoamericanos Unidos (LULAC), una organización de derechos civiles, han participado activamente en ayudar a la comunidad Latina desde que se estableció en el Condado de Denton en 1983. Hace varios meses Denton LULAC fue contactado para ayudar a un hombre hispano desamparado (a quien llamaremos, José). Me ofrecí como voluntario para ayudar a José así que me puse en contacto con la persona que solicitó la asistencia de LULAC (quien le llamaremos Jim). Entrevisté a Jim y él me proporcionó información sobre José. José había vivido en los Estados Unidos por más de 40 años y Jim creía que José tenía más de 63 años de edad. José y su hermano habían vivido juntos durante muchos años hasta que su hermano murió porque le atropelló un coche. José había sido desamparado por muchos años, era un trabajador pero le gustaba beber. José trabajó en la comunidad sobre todo cortando hierba. José tenía cicatrices en su cuerpo después de haber sido quemado en un incendio. Había pasado muchos meses en el hospital como consecuencia de quemaduras en su cuerpo. Como resultado del fuego, José había perdido sus orejas, un par de dedos, tenía cicatrices en todo su cuerpo, tenía el pelo desigual y era casi imposible entenderle cuando hablaba. A veces era difícil relacionar lo que hablaba sobre los hechos debido a su incompleta recolección de eventos y su dificultad en la comunicación. Había perdido mucho movimiento en sus brazos por la cicatrización de la piel pero que no lo guardan de empujar un cortacésped, una vez que se inició para él. Todos sus documentos personales importantes se habían perdido como resultado del fuego. Según Jim,

José era un residente permanente legal y había trabajado muchos años para dos empleadores distintos en su comunidad. Los empleadores habían dejado de funcionar sus respectivos negocios. Jim quería ayudarle obtener beneficios de Seguridad Social de José. Jim era firme que José tenía derecho a esos beneficios.

Jim había previamente intentado ayudar a José pero había pero siempre se encontraba con una pared de ladrillos. Había oído hablar de LULAC y solicitó la asistencia de LULAC. Cuando hablé con Jim, me enteré de otras familias de la comunidad que conocían muy bien a José. Me puse en contacto con ellos y me dieron un poco más de información. Se me ocurrió un día que José podría posiblemente tener un record de policía así que visité la estación de policía para intentar de obtener más información biográfica. Mientras hablaba con uno de los oficiales otro oficial escuchó la conversación y sorpresivamente declaró que él tenía un documento viejo I-94 de José, y es un documento muy importante para establecer su inmigración legal en los Estados Unidos. Lo había encontrado unos días antes. José, Jim y yo visitamos varias oficinas de gobierno, Administración del Seguro Social, Consulado, oficina de seguridad de la patria y, apertura puertas internacional servicios (ODIS) y había hecho varias llamadas a México en un esfuerzo para conseguirle a José sus beneficios. Durante la espera de procesamiento y verificada de la información, una de las hijas de una de las familias con que había visitado había parado para visitar a José. El campo de refugio de José era un pabellón de metal abierto con maquinaria agrícola. Después de llamarle y sin respuesta entro en el refugio sólo para encontrar el cuerpo de José sin vida. Jim organizó una pequeña estela de José. Fue evidente durante la recolección de información que José tenía un corazón muy generoso y era un trabajador a pesar de su problema con la bebida. A pesar de sus debilidades José era fiel a su trabajo incluso en tiempo frío. Jim me dijo que creía que José era su bendición. Varias semanas después de la muerte de José hemos recibido una carta que sus beneficios fueron aprobados. El propósito de esta historia es para recordarnos que a veces perdemos de vista de nuestros sueños y puede tener consecuencias devevastadoras. Jose como muchos mexicanos han llegado a este país con el sueño de hacer una vida mejor. La enfermedad de alcoholismo destrozo esos sueños.

# **Expansion is Good for All: Tejano Democrats State Vice Chair for Youth Comments on City Charter Election**

Fort Worth, TX – Sal Espino, Jr., the State Vice Chair for Youth of Tejano Democrats and its Tarrant County President, is calling for citizens to unite for the continued push and fight for expansion of the Fort Worth City Council in the upcoming City Charter Election that is scheduled in May. In an editiorial/opinion piece that he has submitted to local news outlets, Mr. Espino expressed concerns regarding recent comments made at the City Council meeting that was held on February 2, 2016. "I was shocked, amazed, and disappointed by the comments made by several members of the Fort Worth City Council, especially those made by Councilmen Jordan, Zimmerman, Moon and Shingleton," he said. He noted that he understands the concerns raised about oversized government but disagreed that empowering local neighborhoods by decentralizing power through increasing the size of the Fort Worth City Council was how you avoid too much government and empower citizens to take part in their governance and encourage and cultivate "democracy in action."

Mr. Espino took issue especially with the comments

made by Councilman Singleton that expansion was a Hispanics-only issue: "Councilman Shingleton frames the issues as one that is only about increasing the number of Hispanics on the Fort Worth City Council. While certainly many in the Hispanic community, myself included, believe that expansion of the Fort Worth City Council from its current 8 single-member districts to 10 single-member districts would results in more opportunities for Hispanics to be elected, this issue is more than a minority vs. majority or Hispanic-only issue. Expansion of the City Council is a good for all our neighborhoods because it would empower neighborhoods through decentralization of power. Smaller districts means communities of conflicting interest no longer have to share a City Councilmember." Mr. Espino argues that expansion of the council is good for all communities, regardless of color, creed or politics because it will result in better representation and advocacy by its representatives: "It means that your Councilman won't have to decide on which part of his district to advocate for. This issue has been a growing one, especially for Far North Fort Worth communities that are consistently placed and grouped with communities in the more urban communities inside of Loop 820. These communities have different needs and interests and the current size of the districts makes it incredibly tough for its representatives to advocate for the whole district."

Mr. Espino plans on launching efforts to organize Hispanic votes to raise their voices at the polls in the May Election after the March 1 Primary Election and also plans to reaching out to other communities, regardless of color, creed, or politics to establish a Unity Coalition to support not only expansion of the City Council but all the proposal up for vote.

## A Dream Lost

Members of the League of United Latin American Citizens (LULAC), a civil rights organization for Latinos, have been active in assisting the Latino community since it was first established in Denton County in 1983. Several months ago Denton LULAC was contacted to assist a homeless Hispanic man (whom we will call, Jose). I volunteered to help Jose so I contacted the individual that requested LULAC's assistance (we will call him Jim). I interviewed Jim and he provided me with information about Jose. Jose had lived in the United States for over 40 years and Jim believed Jose was over 63 years of age. Jose and his brother had lived together for many years until his brother died after being hit by a car. Jose had been homeless for many years, was a hard worker but liked to drink. Jose worked in the community primarily cutting grass. Jose

had scars on his body after having been burned in a fire. He had spent many months in the hospital as a result of burns to his body. As a result of the fire, Jose had lost his ears, a couple of fingers, had scarring throughout his body, had patchy hair and it was almost impossible to understand him when he spoke. Sometimes it was difficult to piece facts together because of his incomplete recollection of events and his difficulty in communicating. He had lost a lot of movement in his arms due the scaring of his skin but that did not keep him from pushing a lawn mower once it was started for him. All of his important personal papers had been lost as a result of the fire. According to Jim, Jose was a Legal Permanent Resident and had worked many years for two different employers in their community. Both employers had ceased operating their respective businesses. Jim wanted me to assist with obtaining Jose's Social Security benefits. Jim was adamant that Jose was entitled to those benefits. Jim had previously tried to help Jose but had run into a brick wall. He had heard about LULAC and requested LULAC's assistance. As I talked with Jim, I learned of other families in the community that knew Jose very well. I contacted them and was able to obtain a little information. If occurred to me one day that Jose might possibly have a police record so I visited the police station in order to seek to obtain relevant personal biographical information. While talking to one of the officers another officer, who had just walked in, overheard the conversation and surprisingly stated that he happened to have one of Jose's old I-94's, which is an important document received from the United States Immigration Service. He had happened to find it a few days earlier. Jose, Jim and I visited several government offices, Social Security Administration, Mexican Consulate, Homeland Security Office and, Opening Doors International Services (ODIS) and had made several calls to Mexico in an effort to get Jose his benefits. While waiting for the information to be processed and verified, one of the daughters of one of the families I had visited with had stopped to visit Jose. Jose's shelter camp was an open metal canopy filled with odd farm equipment. After calling to him with no response she entered the shelter only to find Joe's lifeless body. Jim organized a small wake for Jose. What was apparent to me while gathering information was that Jose had a very generous heart and was a hard worker despite his drinking problem. Despite his infirmities he would show up to work for Jim even in cold weather. Jim stated to me that he believed Jose was his blessing. Several weeks after Jose's death we received a letter that his benefits were approved. The purpose of this story is to remind us that sometimes we lose sight of our dreams and it can have devastating consequences. Jose like many Mexicans have come to this country with a dream to make a better life. The disease of alcoholism ravaged his dreams.

# Is there justice in Tarrant County?

Recently we had a visit from a friend of a man in prison for twenty years for sexual abuse of a minor. He was convicted by a duly appointed jury. This could be an open and shut case were it not for a group of friends that believe in his innocence. They have spent thousands of dollars on what appears to be a hopeless cause. At this point in time only the Innocence Project can help him. From hearing his friend the DA was too quick to pull the trigger and

file charges without a thorough investigation. Which brings us to the point of this discussion.

We have a police force because we want to feel secure in our homes. They are there for our protection. The police's job would be easy if everyone was a law-abiding citizen. Unfortunately, that is not the case. A policeman's life is at risk even in the most innocuous of encounters. Of course the broadcast media makes us aware of all these situations across the country not just in our neighborhood. This coverage has a tendency to amplify the acts and makes us more insecure as if the same situation was occurring in a neighborhood.

I can understand the fear a law enforcement officer may have when he threatened. However big that fear may be it is not as great as being in a combat zone where you know that a bullet may be headed your way and that the person that fired that bullet has more and is well armed and well trained. A police officer can practice restraint a soldier cannot. A badge does not make a police officers' actions right. We also have cases of judicial misconduct by judges and District Attorneys.

You may ask, "What does this have to with voting?" The District Attorney is the official that is responsible for investigating all crimes and files charges when there is sufficient proof that a crime was committed. The District Attorney is an elected position. It takes votes to remove a District Attorney that you do not feel is doing an adequate job of trying cases. Yes. The vote is in your hands. Yes, your vote counts.

There have been demonstrations protesting police killing of innocent people. Local officials do not seem to be too concerned about these demonstrations. Probably because they feel secure in their elected position. Only you can change that. By demonstrating these people exercised their constitutional right to express their opinion. Of course, the most powerful constitutional expression that you can make is to vote. If you want justice, that is how you get it.



# **Protest Your Property Taxes**

A new year is here and property tax value notifications will be mailed in April 2016. I have written about protesting property taxes before and would like to remind our readers why it is important to protest your taxes. The process of protesting your taxes is extremely easy and will save you money. Simply fill out and return the Notice of Protest form that comes with your Notice of Appraised Value. The form can be either mailed in or hand delivered. If it is hand delivered the clerk will set up an appointment immediately with one of the appraisers. Instead of meeting with an appraiser immediately, you may want to wait before meeting with an appraiser to determine your property value so that you can do your research into similar properties to see what value they are appraised and taxed at so that you can use this information in your protest. In the appropriate box on the Notice of Protest form, check the reason for your protest. Personally I prefer checking the "value is unequal compared with other properties" box. I check the property values in the neighborhood to see if my property value is consistent with others in the neighborhood. Then I use those property values to determine the value of the property to negotiate with the appraiser. If you would rather use figures of current sales of similar properties, that is also an option. Once you meet with an appraiser, either you agree on the appraised value or you don't. If you don't agree your next step is to go before the Appraisal Board. An appointment will be scheduled for you. You present your evidence which is your research and your argument before the Appraisal Board and they make a ruling on the value of your property. This process takes around 15 minutes. If again you don't agree with the evaluation of the Appraisal Board you can appeal that to an Arbitrator. As the appellant you are required to post \$500. In the event you lose your case that money is used to cover the cost of the Arbitrator and Appraisal District's expense. If you win all but \$50 is returned to you. In my case in 2015, there were three properties that we could not agree on. I decided to take the three properties before an Arbitrator. When we submitted our application along with the \$1500 check, the Appraisal District made a counter offer on the three properties and we agreed on two of the three. Therefore we only had to present one property to the Arbitrator. A letter is sent to the appellant with several arbitrators listed and you select 3 based on your preferences. You will be contacted by the Arbitrator as to the time, date and location to meet. You present your evidence to the Arbitrator and counter what the appraisal district has presented. In order to win, the Arbitrator's value of the property must not exceed half of the value the land owner proposed and the appraisal district proposed value. In other words if the land owner's proposed value is \$70,000 and the Appraisal District's proposed value is \$80,000, then the value proposed by the Arbitrator cannot exceed \$75,000 for the land owner to win the

What I learned from the process in 2015:

1). As a small investor owning more than 10 properties, my interview with the appraisal district should have been conducted in a private office, it was not.

2) While discussing my properties with the appraiser assigned to me, the person next to me, whose property values had been decided previously by

the appraiser helping me, went back and found a

different appraiser, discussed his property again and

had his values lowered. The property owner should have been denied a second visit with an appraiser. The owner's next step of appeal should have been to the Appraisal Board not to another appraiser. How often does this happen? The reason I know about this case is that the conversation took place right in front of me and next to me where we were all seated. The appraiser I was dealing with was drawn into the case next to us and he stated to me after wards what had transpired. I had already understood what had taken place. Do some people get special privileges? I brought this up to a supervisor at a later date and he denied such things happen.

- 3) As the appellant I had inform the Arbitrator and the Appraisal District that I wanted to evaluate my property based on similar properties in the neighborhood-- which is allowed. I discovered that the owners of the properties with the 3 highest property values in my property's neighborhood all had Hispanic last names. This is a very good reason why Hispanics need to protest their taxes.
- 4) I had the understanding that we would be meeting in a neutral environment, however, we met at the Appraisal District. After the arbitration session, the Arbitrator remained in the conference room with the Appraisal District employees. This was unsettling to me because it took away the feeling of being treated impartially. It would be more proper for the Arbitrator to leave the room first or that the Appraisal District employees leave the room before the land owner in order to dismiss any perception of partiality of the Arbitrator to the Appraisal District Employees after the case has been discussed and closed. The Arbitrator is supposed to be impartial not friends with the Appraisal District.

Over all the process is helpful, but a few areas need to be reviewed: 1) the area of the meeting needs to be a neutral place (library conference room for example) and 2) all persons should leave the room at the same time so there is no appearance of undue influence on the Arbitrator by either party. No additional conversation should occur between the Appraisal District and the Arbitrator, nor the landowner and the Arbitrator once the case is closed.
