



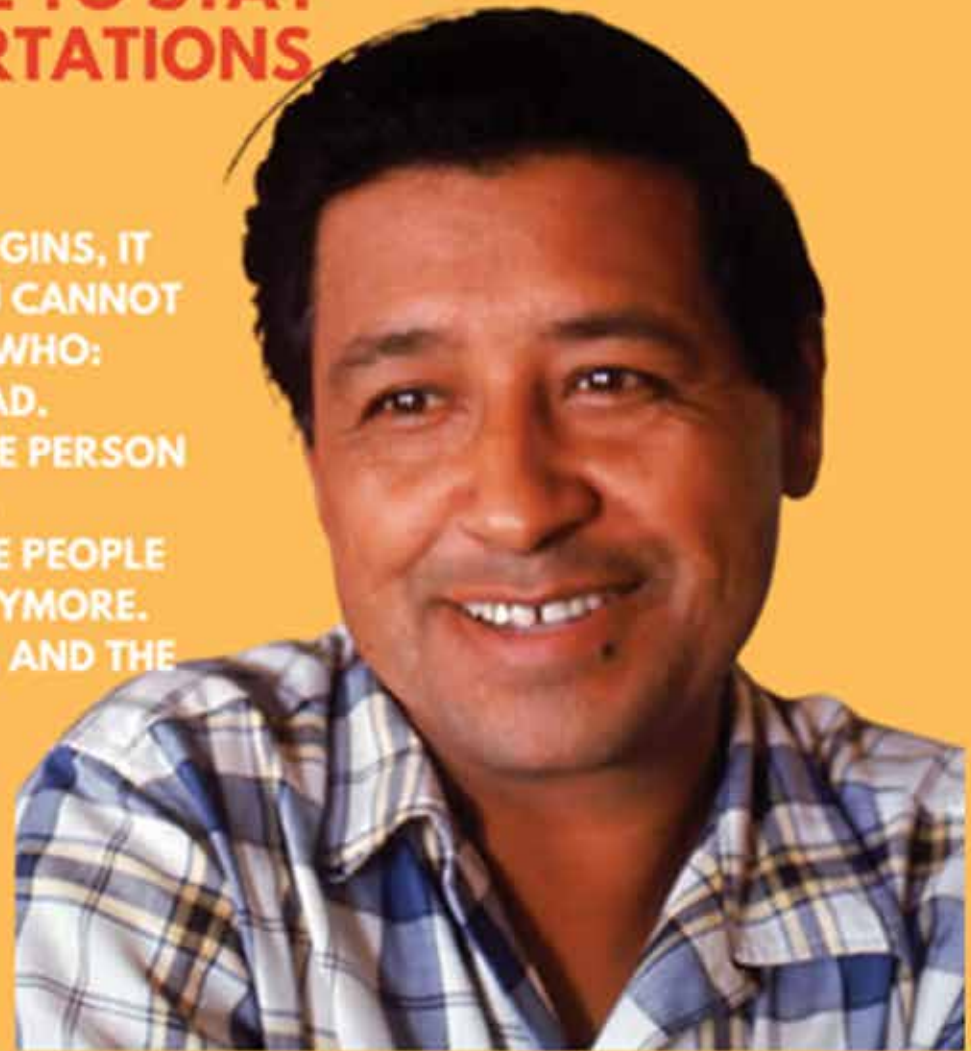

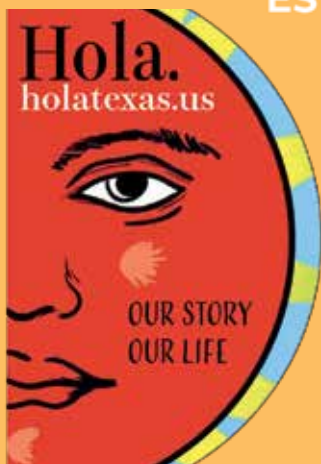

In Mexico, an End to Hugs

Organized crime across parts of Mexico is fueling pressure on the country's new president amid threats from the incoming Trump administration for a more aggressive posture.

Under former Mexican President Andrés Manuel López Obrador, organized crime in Mexico visibly expanded its reach and influence in parts of the country. While Obrador's Fourth Transformation (4T) agenda yielded some positives, there are now warning signs that are cause for concern, all the more so with Donald J. Trump set to return to the White House.

Trump's promise of mass deportations and a war against Mexican cartels—including possible military action by US armed forces on Mexican territory—coincides with the control of large territories in Mexico by organized crime. This phenomenon threatens to complicate US-Mexico relations while causing even greater instability and violence in Mexico, at least in the short and medium term.

Indeed, Trump and his supporters will surely seek to take advantage of the very dynamics fueling criminal activities (such as extortion, human trafficking and drug trafficking, among others) as well as the high-profile confrontations between competing criminal groups in certain areas of Mexico to pressure the Mexican government in talks over US arms sales



and resource extraction.

Criminal paramilitary groups, meanwhile, combined with the enormous corruption and impunity that reigns in large swaths of Mexico, and the protection that businessmen and law enforcement agencies at all levels provide to organized crime, represent a perfect storm for what appears to be in the offing starting January 20. The nomination of retired Colonel Ron Johnson as the new United States ambassador to Mexico, moreover, signals a more aggressive, militaristic approach to bi-lateral relations by the US.

In Mexico, given the delicate situation in some regions, there are even those who would welcome ceding Mexican sovereignty.

So it is that Mexico's new president, Claudia Sheinbaum, will be obliged to deliver results in the face of Trump's threats to impose tariffs, end the US/Mexico/Canada free trade agreement and deploy troops on to Mexican territory. A

heavy-handed strategy can be expected, not unlike what we have seen in El Salvador. This strategy anticipates a period of extreme violence that will add to the current challenges, reversing Obrador's "hugs, not bullets" approach to organized crime. Before the calm comes the storm. Before any hugs new shots will be fired.

Anyone who has worked on the border or along the migratory routes that cross Mexico understands the delicate situation that many in Mexico face. Forced displacement is on the rise, while hotels or other such places that once catered to foreign visitors are now filled by Mexicans displaced by the violence and crime.

Forced recruitment by cartels and crime groups is fanning fear across parts of the country. Many people from states such as Chiapas, Guerrero, Michoacán, Jalisco, Sonora or Sinaloa can no longer live there. The United States has become a refuge sought by more and more Mexicans who today find themselves trapped between Trump's future restrictive immigration

policies and organized crime.

Those familiar with the immigration issue note that the entire border region—from west to east (on the Mexican side)—is controlled by organized crime, which charges a fee to anyone who tries to cross. Corruption, impunity and the inability of the Mexican authorities in recent times have generated an unsustainable situation that in the second Trump era will perhaps justify increased militarism.

Perhaps the greatest problems will be concentrated in the border region (on the Mexican side). Those displaced by

violence seeking to reach the United States, deportees and the main groups dedicated to extortion and drug trafficking will face Trump's aggression, increasing pressure on Sheinbaum's government to adopt a more militaristic strategy.

The renewed security cooperation so sought by the United States within the framework of cross-border relations will perhaps begin to take shape again. The sale of weapons and equipment to the Mexican armed forces and the military training provided by the "good men" of the United States—overseen by Colonel Johnson—appear to be already

underway. We are now entering a new era of shootings.

MASS DEPORTATIONS WOULD BE DISASTROUS FOR THE US ECONOMY

Economists predict the US economy would shrink by at least \$1 trillion.

Republican Presidential candidate Donald Trump's proposal to deport at least 15 million migrants from the US would be disastrous for the American economy, said experts at a news briefing Sept. 12.

Trump has made mass deportations one of the touchstones of his 2024 campaign. He reiterated the threat Sept. 10 evening at the Presidential debate in Philadelphia, Pennsylvania. He evaded a question from ABC News anchor David Muir as to how he would carry out the deportations, but did answer that the number of migrants facing removal could be as high as 21 million. On the campaign trail, the former president has said he would use



the National Guard, the US military, and local law enforcement to carry out the deportations. Roughly 22% of American farmworkers are undocumented migrants, while 15% of construction workers and 8% of care workers are also undocumented. Lost Sales Revenue

The US would lose about \$100 billion in federal and state tax revenues, said Dr. Robert Lynch, co-author of "The Economic Impact on Citizens and Authorized Immigrants of Mass Deportation." Inflation would rise by about 3% he predicted at the news briefing, organized by America's Voice.

“On the demand side effect, we have 8 million undocumented workers who spend hundreds of millions of dollars in the US. Deport them, and you lose that revenue,” said Lynch, professor emeritus at the University of Washington.

“The economy of America shrinks,” said Lynch, noting also that low-skilled white men who work in blue collar jobs would be hardest hit. Wages go down when the economy shrinks, as small businesses shutter or cut down their labor force due to revenue loss, he explained.

The notion that undocumented immigrants are stealing jobs from American workers is a false narrative, said Lynch. “Americans are not going to go out in the blazing heat to pick cotton or peanuts,” he said. “Undocumented immigrants take jobs that American workers will not do.” ‘Pet Eating Haitians’

At the news briefing, several speakers noted that Trump has demonized migrants to appeal to his ‘Make America Great

Again’ base. But there is scant evidence of such appeal to voters outside the base. Zachary Mueller, research director at America’s Voice, said Republicans have spent \$458 million in television ads and a similar amount on social media ads to promote anti-immigrant messaging. “But it has not delivered at the ballot box.”

The most discussed moment of the debate was when Trump alleged that Haitian immigrants in Springfield, Ohio were capturing pets and eating them. City officials have said there is no evidence of such claims. “Trump has dehumanized a group of people, and cast them as an existential threat,” said Mueller. “He is engaging in racist theory, and it is clear there are going to be consequences.”
SAVE Act

Earlier that morning, Springfield City Hall received a bomb threat, which forced all workers there to evacuate. Mayor Rob Rue said the perpetrators had “used hateful language towards immigrants and

Haitians in our community.”

The Safeguard American Voter Eligibility Act — SAVE — requires voters to provide documentary proof of citizenship at the time of registration. The pending legislation, known as a continuing resolution, has been attached to the budget bill. House Speaker Mike Johnson has said he will not allow the budget bill to pass without the SAVE Act also being passed, even if it means a government shutdown, reported the Associated Press.
False Narratives

Jonah Minkoff-Zern, co-director of the Public Citizen’s Democracy Campaign, said the statements made in the SAVE Act are not verified by facts. Incidents of non-citizen voting are extremely rare.

“People would not risk their livelihoods and their families to illegally cast a vote,” said Minkoff-Zern. “Using this blatantly false narrative.

I’m a proud, first-generation, college-educated and gay Mexican American with undocumented family in the United States, including a mother who was previously deported to Mexico, and I experienced homelessness as a child. I am everything Democrats claim to support, right?

Wrong.

Democrats have accepted a progressive platform, ignoring decades worth of change and focusing on erroneous issues. They have built campaigns on a foundation of misleading ads and fake vibes.

Voting for Donald Trump does not make me racist, sexist, misogynistic, homophobic or any other “ist” and “ic”

I’ve been called. I, along with more than half of the voting public in America, am sick of the self-righteous and label-obsessed left alienating us over differing opinions.

In her concession speech, Vice President Kamala Harris claimed to have built strong coalitions. What she did was the opposite. She did not motivate enough Black voters, Latino voters, Asian voters, Jewish voters, union voters and

female voters to cast their ballots for her. Fewer women voted for Harris than they did Joe Biden, even with abortion being a top issue. To the very end, Harris ignored the data; she ignored what voters needed.

The party spent the last four years demonizing men and blaming us for all of society's ills. Then they spent several months drinking beer, releasing camo hats and attempting to "love" guns to desperately win our votes. My concerns go beyond just immigration. I am a U.S.-born Mexican American. We are the youngest demographic in the U.S. What matters to me and many Latinos like me are obtaining jobs, paying for the costs of living, buying a home, growing and helping our families, and making sure the American Dream is attainable and still alive. Over the last four years, all of that has become harder. If you think it hasn't or haven't felt it, consider yourself blessed. This situation clearly upset many other Latinos who broke from generational loyalty to Democrats.

It was also rich to have Democratic leaders such as Michele Obama, whose personal worth is reportedly tens of millions, say that rich people take more than their fair share. She was sandwiched between billionaires Gov. JB Pritzker and Oprah Winfrey at the DNC in Chicago. Pritzker even taunted Trump on not being a "real billionaire," which was extremely unrelatable. Billionaire Mark Cuban also hit the campaign trail for Harris. Know Your Rights with ICE

If approached by ICE (Immigration and Customs Enforcement) agents, you have rights!

What can I do if ICE is at my door?

- You do not have to immediately open the door for ICE and you do not have to speak to ICE.
- From **behind the closed door**, you may ask them who they are and to show their badge, ID or business card through the window or peephole or to pass it under the closed door.
- You can ask if they have a **judicial warrant**:

If they say **No**, you do not have to let them in. You may say,

"I do not want to speak with you."

If they say **Yes**, you can ask them to slide it under the door. To know if it is a judicial warrant, look to see who signed the warrant.

A judicial warrant is a warrant from a court, signed by a judge. For example, judge signatures may have "Honorable/Hon." "Judge" "Justice" or "Magistrate" in front of them.

- In an emergency, such as a threat to public safety or a threat to someone's life, ICE can come in without asking your permission. If this happens, you still do not have to speak to ICE.
- If ICE is looking for someone, **you do not need to speak**. If you choose to speak, you can ask ICE to leave contact information. While you do not need to tell ICE where the person is located, providing false information puts you at risk.

What can I do if ICE is inside my home?

- If ICE enters your home without your permission, you can tell them clearly: "**I do not consent to you being in my home. Please leave.**" Saying this may not always stop them, but it may help any future legal case.
- If ICE starts to search rooms or items in your home, you can tell them, "**I do not consent to your search.**" You can continue to **repeat this** if they continue to search without consent.
- You can tell them if there are **children** or **other vulnerable residents** in your home.

What can I do if ICE stops me on the street or in public?

- Before you say anything, you can ask, "**Am I free to go?**"

If they say **Yes**: you can say,

"I don't want to answer your questions"

If they say **No**: you can say,

"I want to remain silent."

If ICE agents try to search your pockets or belongings, you can say,

"I do not consent to a search."

If they search you anyway, you cannot physically stop them, but clearly saying it may be important in any future legal case.

What can I do if ICE is at my workplace?

- ICE can enter the **public space** of any workplace without needing any type of warrant.
- **Public spaces** may include: office lobby, supermarket, retail store, or dining area of a restaurant.
- ICE cannot legally enter the **private space** of a workplace unless they have the **permission of your employer** or a **judicial warrant**.
- **Private spaces** are employee-only areas that may include the break room or storage room of a workplace.
- **Employers can** ask ICE to show their identification and ask if ICE has a judicial warrant
- As in all public spaces, if approached by ICE at work, **you do NOT have to answer their questions** and can direct them to your employer.
- As always, if ICE agents try to search your pockets or belongings, you can say, **"I do not consent to a search."** If they search you anyway, you cannot physically stop them, but clearly saying you do not consent may be important in any future legal cases.

What if I am being detained?

- You can tell ICE if you have **medical issues** or need to **arrange for childcare**.
- ICE agents **may not speak your native language**. You can **request an interpreter** for any conversation with ICE or for any appointment or hearing you are given.
- You **do not need to sign any documents** or **answer any questions** before you speak with a lawyer.
- Once detained, you will have **the right to make phone calls** to your family, friends, community leaders, or attorney.
- In detention, **you can receive visitors** including your family, friends, community leaders and attorney. Note that **each jail has its own rules** that visitors must review beforehand.
- If you are being detained, **people in the community may film ICE**, so long as they do not interfere with officers. If ICE agents are trying to talk to or arrest you, starting or continuing to film may put you at risk.
- **You can share with your attorney**, once you have one, **any audio, video, or written notes about your arrest from you or someone who saw your arrest**.

If you or a loved one is at risk of deportation, you can make a plan.

- You can get free and confidential immigration legal advice. Immigrant New Yorkers can call **ActionNYC** at **1-800-354-0365** between 9AM – 6PM, Monday through Friday or call 311 and say "ActionNYC."
- You can **choose an emergency contact and memorize their phone number**. An emergency contact can be someone you trust – a family member, friend, community leader, or a lawyer.
- You can **organize your documents** and keep them in a safe place that your emergency contacts have access to.

En México, el fin de los abrazos

El crimen organizado en partes de México está alimentando la presión sobre el nuevo presidente del país en medio de amenazas de la administración entrante de Trump para que adopte una postura más agresiva.

Bajo el mandato del expresidente mexicano Andrés Manuel López Obrador, el crimen organizado en México amplió visiblemente su alcance e influencia en algunas partes del país. Si bien la agenda de la Cuarta Transformación (4T) de Obrador arrojó algunos aspectos positivos, ahora hay señales de advertencia que son motivo de preocupación, más aún con el regreso de Donald J. Trump a la Casa Blanca.

La promesa de Trump de deportaciones masivas y una guerra contra los cárteles mexicanos, incluida una posible acción militar de las fuerzas armadas estadounidenses en territorio mexicano, coincide con el control de grandes territorios en México por parte del crimen organizado. Este fenómeno amenaza con complicar las relaciones entre Estados Unidos y México, al tiempo que provoca una inestabilidad y violencia aún mayores en México, al menos en el corto y mediano plazo.

De hecho, Trump y sus partidarios seguramente buscarán aprovecharse de las

mismas dinámicas que alimentan las actividades criminales (como la extorsión, la trata de personas y el narcotráfico, entre otras), así como de los enfrentamientos de alto perfil entre grupos criminales rivales en ciertas áreas de México para presionar al gobierno mexicano en las conversaciones sobre la venta de armas y la extracción de recursos de Estados Unidos.

Mientras tanto, los grupos criminales paramilitares, combinados con la enorme corrupción e impunidad que reina en grandes franjas de México, y la protección que los empresarios y las agencias de aplicación de la ley en todos los niveles brindan al crimen organizado, representan una tormenta perfecta para lo que parece estar a la vista a partir del 20 de enero. Además, el nombramiento del coronel retirado Ron Johnson como nuevo embajador de Estados Unidos en México indica un enfoque más agresivo y militarista de las relaciones bilaterales por parte de Estados Unidos.

En México, dada la delicada situación en algunas regiones, incluso hay quienes verían con buenos ojos ceder la soberanía mexicana.

Así es que la nueva presidenta de México, Claudia Sheinbaum, se verá obligada a entregar resultados ante las amenazas de Trump de imponer aranceles, poner fin al



tratado de libre comercio entre Estados Unidos, México y Canadá y desplegar tropas en territorio mexicano. Se puede esperar una estrategia de mano dura, no muy diferente a lo que hemos visto en El Salvador. Esta estrategia anticipa un período de violencia extrema que se sumará a los desafíos actuales, revirtiendo el enfoque de “abrazos, no balazos” de Obrador hacia el crimen organizado. Antes de la calma llega la tormenta. Antes de cualquier abrazo, se dispararán nuevos tiros.

Cualquiera que haya trabajado en la frontera o a lo largo de las rutas migratorias que atraviesan México entiende la delicada situación que enfrentan muchos en México. El desplazamiento forzado va en aumento, mientras que los hoteles u otros lugares similares que antes atendían a visitantes extranjeros ahora están ocupados por mexicanos desplazados por la violencia y el crimen.

El reclutamiento forzado por parte de cárteles y grupos criminales está avivando el miedo en partes del país. Muchas personas de estados como Chiapas, Guerrero, Michoacán, Jalisco, Sonora o

Sinaloa ya no pueden vivir allí. Estados Unidos se ha convertido en un refugio buscado por cada vez más mexicanos que hoy se encuentran atrapados entre las futuras políticas migratorias restrictivas de Trump y el crimen organizado.

Quienes están familiarizados con el tema migratorio señalan que toda la región fronteriza —de oeste a este (del lado mexicano)— está controlada por el crimen organizado, que cobra una tarifa a cualquiera que intente cruzar. La corrupción, la impunidad y la incapacidad de las autoridades mexicanas en los últimos tiempos han generado una situación insostenible que en la segunda

era Trump tal vez justifique el aumento del militarismo.

Quizás los mayores problemas se concentrarán en la región fronteriza (del lado mexicano). Los desplazados por la violencia que buscan llegar a Estados Unidos, los deportados y los principales grupos dedicados a la extorsión y el narcotráfico enfrentarán la agresión de Trump, aumentando la presión sobre el gobierno de Sheinbaum para que adopte una estrategia más militarista.

Las deportaciones masivas serían desastrosas para la economía de EE.UU.

La propuesta del candidato presidencial republicano Donald Trump de deportar al menos a 15 millones de migrantes de Estados Unidos sería desastrosa para la economía estadounidense, dijeron expertos en una conferencia de prensa el 12 de septiembre.

Trump ha hecho de las deportaciones masivas una de las piedras angulares de su campaña para 2024. Reiteró la amenaza el 10 de septiembre por la noche en el debate presidencial

en Filadelfia, Pensilvania. Evadió una pregunta del presentador de ABC News, David Muir, sobre cómo llevaría a cabo las deportaciones, pero respondió que el número de migrantes que enfrentan la deportación podría ascender a 21 millones. En la campaña electoral, el expresidente ha dicho que utilizaría la Guardia Nacional, el ejército estadounidense y las fuerzas del orden locales para llevar a cabo las deportaciones.

Aproximadamente el 22% de los trabajadores agrícolas estadounidenses son migrantes indocumentados, mientras que el 15% de los trabajadores de la construcción y el 8% de los trabajadores de cuidados también son indocumentados.

Pérdida de ingresos por ventas

Estados Unidos perdería alrededor de 100.000 millones de dólares en ingresos fiscales federales y estatales, dijo el Dr. Robert Lynch, coautor de “El impacto económico en los ciudadanos e inmigrantes autorizados de la deportación masiva”. La inflación aumentaría alrededor de un 3%, predijo en la conferencia de prensa, organizada por America’s Voice.

“En el efecto secundario de la demanda, tenemos 8 millones de trabajadores indocumentados que gastan cientos de millones de dólares en Estados Unidos. Si los deportas, pierdes esos ingresos”, dijo Lynch, profesor emérito de la Universidad de Washington. “La economía de Estados Unidos se contrae”, dijo Lynch, señalando también que los hombres blancos poco calificados que trabajan en empleos de cuello azul serían los más afectados. Los salarios bajan cuando la economía se contrae, ya que las pequeñas empresas cierran o reducen su fuerza laboral debido a la pérdida de ingresos, explicó.

La noción de que los inmigrantes indocumentados están robando empleos de trabajadores estadounidenses es una narrativa falsa, dijo Lynch. “Los estadounidenses no van a salir en el calor abrasador a recoger algodón o maní”, dijo.

En la conferencia de prensa, varios oradores señalaron que Trump ha demonizado a los migrantes para apelar a su base de ‘Make America Great Again’. Pero hay poca evidencia de tal atractivo para los votantes fuera de la base. Zachary Mueller, director de investigación de America’s Voice, dijo que los republicanos han gastado 458 millones de dólares en anuncios de televisión y una cantidad similar en anuncios en las redes sociales para promover mensajes antiinmigrantes. “Pero no ha dado resultados en las urnas”.

El momento más discutido del debate fue cuando Trump alegó que los inmigrantes haitianos en Springfield, Ohio, estaban capturando mascotas y comiéndoselas. Los funcionarios de la ciudad han dicho que no hay evidencia

de tales afirmaciones.

“Trump ha deshumanizado a un grupo de personas y las ha presentado como una amenaza existencial”, dijo Mueller. “Está incurriendo en una teoría racista y está claro que va a haber consecuencias”.

Ley SAVE Esa misma mañana, el Ayuntamiento de Springfield recibió una amenaza de bomba, que obligó a evacuar a todos los trabajadores. El alcalde Rob Rue dijo que los perpetradores habían “usado un lenguaje de odio hacia los inmigrantes y haitianos en nuestra comunidad”.

La Ley de Protección de la Elegibilidad de los Votantes Estadounidenses (SAVE, por sus siglas en inglés) requiere que los votantes proporcionen prueba documental de ciudadanía en el momento del registro. La legislación pendiente, conocida como resolución continua, se ha adjuntado al proyecto de ley de presupuesto. El presidente de la Cámara de Representantes, Mike

Johnson, ha dicho que no permitirá que se apruebe el proyecto de ley de presupuesto sin que también se apruebe la Ley SAVE, incluso si eso significa un cierre del gobierno, informó Associated Press. Narrativas falsas

Jonah Minkoff-Zern, codirector de la Campaña de Democracia de Public Citizen, dijo que las declaraciones hechas en la Ley SAVE no están verificadas por hechos. Los incidentes de votación de no ciudadanos son extremadamente raros.

“La gente no arriesgaría sus medios de vida y sus familias para votar ilegalmente”, dijo Minkoff-Zern. “Usando esta narrativa descaradamente falsa, Trump está marcando la pauta para interrumpir las elecciones si no salen como él quiere”.

Conozca sus derechos con ICE

Si se le acercan agentes de ICE (Servicio de Inmigración y Control de Aduanas), ¡tiene derechos!

¿Qué puedo hacer si ICE está en mi puerta?

Puede preguntar si tienen una orden judicial:

No tiene que abrirle la puerta inmediatamente a ICE y no tiene que hablar con ICE.

Desde detrás de la puerta cerrada, puede preguntarles quiénes son y mostrar su credencial, identificación o tarjeta de visita a través de la ventana o mirilla o para pasarla por debajo de la puerta cerrada.

Una orden judicial es una orden de un tribunal, firmada por un juez. Por ejemplo Las firmas de los jueces pueden tener "Honorable/Honorable." "Juez" "Justicia" o "Magistrado" en frente a ellos.

En una emergencia, como una amenaza a la seguridad pública o una amenaza a la vida de alguien, ICE puede entrar sin pedirte permiso. Si esto sucede, aún no tiene que hablar con ICE.

Si ICE está buscando a alguien, usted no necesita hablar. Si decide hablar, puede pedirle a ICE que Deje la información de contacto. Si bien no es necesario que le diga a ICE dónde se encuentra la persona, siempre que La información falsa lo pone en riesgo.

¿Qué puedo hacer si ICE está dentro de mi casa?

Si ICE entra a su casa sin su permiso, usted puede decirles claramente: "No doy mi consentimiento para que usted Estar en mi casa. Por favor, váyanse". Decir esto no siempre los detiene, pero puede ayudar en cualquier futuro caso legal.

Si ICE comienza a registrar habitaciones o artículos en su casa, usted puede decirles: "No doy mi consentimiento para que usted búsqueda". Puede seguir repitiendo esto si continúan buscando sin consentimiento.

Puede decirles si hay niños u otros residentes vulnerables en su hogar.

En una emergencia, como una amenaza a la seguridad pública o una amenaza a la vida de alguien, ICE puede entrar sin pedirte permiso. Si esto sucede, aún no tiene que hablar con ICE.

Si ICE está buscando a alguien, usted no necesita hablar. Si decide hablar, puede pedirle a ICE que Deje la información de contacto. Si bien no es necesario que le diga a ICE dónde se encuentra la persona, siempre que La información falsa lo pone en riesgo.

¿Qué puedo hacer si ICE me detiene en la calle o en público?

Antes de decir algo, puedes preguntar: "¿Puedo irme?"

Si te dicen que sí, puedes decir:

"Yo no

¿Quieres responder a tu preguntas"

Si te dicen que no, puedes decir:

"Quiero quedarme silencioso".

Si los agentes de ICE intentan registrar su bolsillos o pertenencias, se puede decir,

"No doy mi consentimiento a una búsqueda".

Si te registran de todos modos, no puede detenerlos físicamente, pero Decir claramente que puede ser importante en cualquier caso legal futuro.

No es asesoramiento legal. Consulte a un abogado para obtener asesoramiento legal.

¿Qué puedo hacer si ICE está en mi lugar de trabajo?

ICE puede ingresar al espacio público de cualquier lugar de trabajo sin necesidad de ningún tipo de orden judicial.

Los espacios públicos pueden incluir: vestíbulo de oficina, supermercado, tienda minorista o comedor de un restaurante.

ICE no puede ingresar legalmente al espacio privado de un lugar de trabajo a menos que tengan el permiso de su empleador o una orden judicial.

Los espacios privados son áreas exclusivas para empleados que pueden incluir la sala de descanso o el almacén de un lugar de trabajo.

Los empleadores pueden pedirle a ICE que muestre su identificación y preguntar si ICE tiene una orden judicial

Como en todos los espacios públicos, si ICE se le acerca en el trabajo, NO tiene que responder a sus preguntas y puede dirigirlos a su empleador.

Como siempre, si los agentes de ICE intentan registrar sus bolsillos o pertenencias, usted puede decir: "No doy mi consentimiento para una búsqueda". Si te registran de todos modos, no puedes detenerlos físicamente, pero diciendo claramente que no lo haces El consentimiento puede ser importante en cualquier caso legal futuro.

¿Qué pasa si estoy detenido?

Puede decirle a ICE si tiene problemas médicos o necesita hacer arreglos para el cuidado de los niños.

Es posible que los agentes de ICE no hablen su idioma nativo. Puede solicitar un intérprete para cualquier conversación con ICE o para cualquier cita o audiencia que se le dé.

No necesita firmar ningún documento ni responder ninguna pregunta antes de hablar con un abogado.

Una vez detenido, tendrá derecho a hacer llamadas telefónicas a su familia, amigos, comunidad líderes, o abogado.

En la detención, puede recibir visitas, incluidos su familia, amigos, líderes comunitarios y abogado. Tenga en cuenta que cada cárcel tiene sus propias reglas que los visitantes deben revisar de antemano.

Si usted está siendo detenido, las personas de la comunidad pueden filmar a ICE, siempre y cuando no interfieran con la Oficiales. Si los agentes de ICE están tratando de hablar con usted o arrestarlo, comenzar o continuar filmando puede ponerlo en riesgo.

Puede compartir con su abogado, una vez que tenga uno, cualquier audio, video o notas escritas sobre su arresto de usted o de alguien que vio su arresto.

Puede organizar sus documentos y guardarlos en un lugar seguro para su emergencia. Los contactos tienen acceso a.

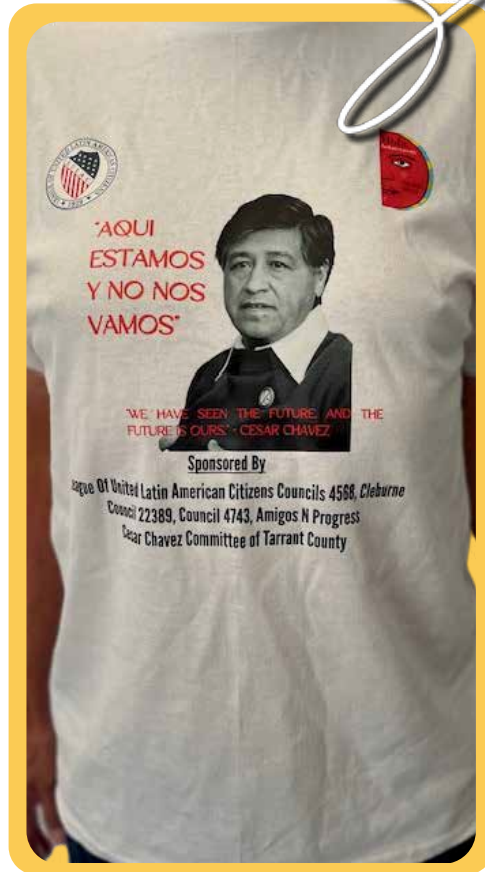
